



# Philadelphia's Guide to Sharing Public Spaces

- **Philadelphia public spaces are for everyone.** Philadelphia sidewalks and public spaces should be available for all to use and to peacefully enjoy the City.
- **Without discrimination.** No one should be discriminated against in the use of public spaces, and poverty should not be criminalized.
- **Enforcement requires prioritizing.** The City works to deploy limited enforcement resources by prioritizing enforcement against activities causing the most harm.

## Sidewalks & Public Spaces

Philadelphia Police Department provides enforcement, in some instances with support from Homeless Outreach. Enforcement requires prioritizing. The City works to deploy limited enforcement resources by prioritizing enforcement against activities causing the most harm.

### Prohibited

**Sitting, lying, or placing one's belongings** or other objects upon the public sidewalk, in such manner as to unreasonably and significantly impede or obstruct the free passage of pedestrians.\*

Penalty: Verbal warning, written warning, \$20 fine

**Soliciting money** for any purpose on the public sidewalk in an aggressive manner likely to cause a reasonable person to fear bodily harm to oneself or another, or damage to or loss of property. \*\*

Penalty: Verbal warning, written warning, \$20 fine

**Urinating or defecating** in any public space

Penalty: Up to \$2,000 fine

**Consuming alcoholic beverages** or carrying or possessing an open container - Penalty: \$50-300 fine

**Possessing or purchasing** controlled substances

Criminal offense

**Possessing or smoking** small amounts of marijuana

Penalty: Possession - \$25 Smoking - \$100

**Selling** controlled substances - Criminal offense

**Littering** - Penalty: \$300 fine

**Removing, defacing, or interfering in** public or private property

Penalty: \$50 - \$300 fine or community service, \$300 for graffiti

**Smoking in** enclosed public spaces or in any public transportation vehicles or stations - Penalty: \$300 fine

**Vending or selling** without a license

Penalty: Up to \$2,000 fine

**Disorderly conduct** including fighting, violent or tumultuous behavior, making unreasonable noise, using obscene language or gestures or creating a hazardous or physically offensive condition, if it causes public inconvenience

Penalty: \$100 fine

### Discouraged

**Public outdoor serving of food** (Requires a permit and meeting standards related to hygiene of servers, waste disposal, and storage/handling of food) - Health Department enforces

\* This provision applies City-wide. Sitting and lying on the public sidewalk are more generally prohibited in Center City; University City; the 1st, 4th, 6th and 7th Council Districts; and on several major commercial thoroughfares. See Philadelphia Code Section 10-611 for details. \*\*This provision applies only in Center City; University City; the 1st, 4th, 6th and 7th Council Districts; and on several major commercial thoroughfares. ## Parks

### Prohibited

**Camping or using a tent** as shelter

Enforcement Agency: Park Ranger or Police

**Park use after 10 pm**

Enforcement Agency: Park Ranger or Police

**Having fires** anywhere outside of designated stone fireplaces, barbecue stands and portable charcoal stoves

Enforcement Agency: Park Ranger or Police

**Amplified sound** (except with an event permit)

Enforcement Agency: Park Ranger or Police

### Permitted

**Serving food** for 75 or more people (requires a picnic permit)

See also "Public Outdoor Serving of Food" (above)

Enforcement Agency: Park Ranger or Health Department

**Serving food** for fewer than 75 people as long as it does not result in littering; See "Public Outdoor Serving of Food" (above)

Enforcement Agency: Park Ranger or Health Department



## Public Transit

### Prohibited

**Obstructing** the flow of pedestrian traffic

Penalty: Up to \$300 fine

**Smoking in** vehicles, in concourses, or at stations

Penalty: Up to \$300 fine

**Speaking to** others using loud or abusive language

Penalty: Up to \$300 fine

**Soliciting and loitering** in transportation centers

Penalty: Up to \$300 fine

**Littering** - Penalty: Up to \$300 fine

### Discouraged

**Lying down or placing feet or personal belongings** on any bench or seat - Warning: Removal from system

**Taking up more** than one seat

Warning: Removal from system

**Bathing in** public restrooms

Warning: Removal from system
